I-20 CHECKLIST

To receive an I-20, you must submit the following:

1. A copy of your passport
2. An original bank letter
3. Your complete international street address (a P.O. Box will not be accepted)
4. A completed and signed Undergraduate I-20 Request form
5. A completed Transfer Eligibility Statement (for students currently attending school in the U.S.)

A. Certified bank letter that

1. is an original (copies **will not** be accepted);
2. is certified (a bank seal or stamp must appear on the bank letter);
3. is a document that states at least the amount (in dollars) required for what you plan to study (see Comprehensive Charges chart), additional funds must be added for dependents (include U.S. dollar exchange rate); and
4. is not over six months old from the date you plan to attend Florida Tech.

B. Affidavit of Support form (I-134, if using a U.S. sponsor). This form must be

1. an original, and will be required to obtain your visa from the embassy;
2. notarized;
3. **not over** six months old from the date you plan to attend; and
4. able to demonstrate support for **at least** the amount required for what you plan to study (see Comprehensive Charges chart).

C. Sponsorship letter that

1. is an original (copies will not be accepted);
2. is not over six months old from the date you plan to attend;
3. is a clear outline of specific dollar amounts and items the sponsorship covers (see Comprehensive Charges chart);
4. is an original letter from sponsor or sponsoring agency stating their guarantee to finance your education; and
5. is a document containing billing instructions. **Only sponsors in the United States will be billed directly. Students sponsored outside the United States must make private arrangements for payment of fees, unless the sponsoring agency maintains a U.S. billing address.**
